Eagle Spirit Dachshunds, (herein after referred to as "Breeder"), to the best of their knowledge, has made every effort to provide you with a happy, healthy puppy/dog and guarantees that the above puppy/dog is in good health, current on all vaccines and worm medicines as stated in the health records provided at the time of sale, but do NOT guarantee final adult size, conformation, color, coat pattern or fertility of the above puppy/dog. The deposit is part of the purchase price, but is nonrefundable. We require the Purchaser(s) to have the puppy/dog examined by a licensed veterinarian within 72 hours of taking possession of the puppy/dog or this guarantee will be null and void. Please keep a copy of this exam as proof of having it done within the 72 hour period, and also keep a copy of this contract. If this puppy is found to have a life threatening hereditary congenital defect at this exam, the breeder must be notified IMMEDIATELY. At this time, the breeder can and may require a secondary exam from a different DVM (AT NO EXPENSE TO THE BREEDER). These visits, lab work, and findings will need to be properly documented, signed by examining Physician and forwarded directly to the breeder. A replacement puppy/dog of the same sex and of equal value will be given when available (usually within 12 months) after the purchased puppy/dog is returned to the Breeder along with all Kennel Club registration papers (AT NO EXPENSE TO THE BREEDER). Breeder will not be responsible for any veterinarian bills incurred by the Purchaser(s). (NO MONEY WILL BE REFUNDED AT ANY TIME).

This puppy/dog is guaranteed for 3 months. In the unlikely event of this puppy's death in the first 3 months, due to a hereditary congenital defect, the Purchaser(s) will be entitled to a replacement puppy/dog of the same sex and of equal value (NO MONEY WILL BE REFUNDED AT ANY TIME) when available (usually within 12 months). A statement from a licensed veterinarian confirming cause of death along with lab work is required before any action will be taken by the Breeder. If cause is unknown, an autopsy is required. The Breeder will not be responsible for any veterinarian bills incurred by the Purchaser.

This contract/health guarantee applies only to the initial Purchaser(s) shown above. If ownership of the puppy/dog changes then this contract/health guarantee becomes null and void. Should the above puppy/dog die while in the breeder's care, prior to delivery, then the Purchaser(s) may choose another puppy/dog of equal value when one becomes available.

This guarantee does not include injuries, fleas, mites, cocei, giardia, or any other intestinal worms/parasites, as they are common in puppy/puppy/dogs and puppies. Breeder will not be responsible for Parvo, Distemper or Carnona Virus after 24 hours of the sale, as these are highly contagious diseases and can be contracted immediately after leaving the Breeder. There is no guarantee on eye sight or hearing because puppies are not examined by a specialist. Breeder will not be responsible for health problems that are detected after this initial DVM visit, except where stated in this contract. Breeder also reserves the right to refuse the replacement of any puppy returned for temperament, hip problems, or any other medical issues if neglect or abuse by owner is

suspected. This includes but is not limited to over feeding, under feeding, excessive exercise, and improper socialization.

The Breeder makes no guarantees, expressed or implied, under this contract except as stated in these pages. UNDER NO CIRCUMSTANCE OF ANY KIND WILL MONEY (INCLUDING PUPPY/DOG AMOUNT OR SHIPPING FEES). BE REFUNDED. UNDER NO CIRCUMSTANCE IS THE BREEDER RESPONSIBLE FOR ANY VET BILLS INCURRED AFTER TIME OF TRANSFER. Purchaser(s) releases Eagle Spirit Dachshunds, the breeders and their estates from any and all liabilities and/or damages by fault of this puppy/dog after the time of sale. These damages include, but are not limited to, destruction of property/or physical damage to any person or group of people.

Purchaser agrees that he/she has read, fully understands and agrees to ALL terms of this contract, and that this contract is under the jurisdiction of the state of West Virginia, in the county of Kanawha. It is agreed that the place of venue shall be in Kanawha County, West Virginia.
